This Privacy Policy describes how we collect, use, process, and disclose your information, including personal information, in conjunction with your access to and use of All-Wall.com's website and/or mobile applications. We may change or add to this Privacy Policy, so we encourage you to review it periodically.

When this Privacy Policy mentions "All-Wall.com," "we," "us," or "our," it refers to All-Wall and its website All-Wall.com ("All-Wall.com"), which is the company that is responsible for your information under this Privacy Policy ("Data Controller").

If you see an undefined term in this Privacy Policy (such as "All-Wall.com Platform(s)"), it has the same definition as in our [Terms of Use](#).

All-Wall.com is located in the United States. Information collected on our website and applications is stored in the United States; therefore, your information may become subject to U.S. law. By using the All-Wall.com Platform(s), you consent to the transfer of your data overseas and across borders, and from your country or jurisdiction to other countries or jurisdictions around the world. The laws governing data in your home country may differ from those in the countries to which data is transferred. By accessing and using our website and mobile applications, you consent to the transfer of your data in this manner.

1. INFORMATION WE COLLECT

1.1. Information You Provide To Us

1.1.1. Information That Is Necessary For The Use Of All-Wall.Com's Website And/Or Mobile Applications.

We ask for and collect the following personal information about you when you use All-Wall.com's website or mobile applications, which is necessary for the performance of a contract between you and us (e.g., placing an order) and to allows us to comply with various legal obligations. Without this information, we may not be able to provide you with all of the requested services.

- **Account Information.** When you sign up for a All-Wall.com account, via our website or mobile applications, we require certain information such as your first and last name, e-mail address, username, and password. If you choose to register by using a third-party account (such as your Facebook account), please see "Information We Collect from Third Parties" below.

- **Order Information.** When you place an order on our website or sign up for a subscription service, we may request that you provide additional information such as your billing and shipping addresses and phone number.
- **Payment Information.** To facilitate processing of payments on our website, we require you to provide certain financial information (e.g., your credit card number).
- **Communications with All-Wall.com.** When you communicate with All-Wall.com via our website or mobile applications (e.g., for customer service inquiries), we collect information about your communication and any information you choose to provide.

1.1.2. Information You Choose To Provide To Us.

You may choose to provide us with additional personal information in order to obtain a better user experience when using the All-Wall.com Platform(s). This additional information will be processed based on your consent or All-Wall.com's legitimate interests, as specified below:

- **Additional Profile Information.** You may choose to provide additional information as part of your All-Wall.com profile, such as gender, first and last name, preferred language, etc. This information, if you choose to provide it, may be part of a public profile page and will be publicly visible to others.
- **Other Information.** You may otherwise choose to provide us information when you fill in a form, conduct a search, update or add information to your All-Wall.com profile, respond to surveys, post to community forums or on product reviews, participate in promotions, or use other features on the All-Wall.com Platform(s). This information is processed based on your consent.

1.2. Information We Get From Your Use Of Our Platform(S) And Services

When you use All-Wall.com's Platform(s), we automatically collect information, including personal information, about the services you use and how you use them, such as information about how you use or interact with our website and mobile applications, view or interact with our ads and content, and information about your computer or mobile device. This information may include:

- **Usage Information.** We collect information about your interactions with our website and mobile applications such as the pages or content you view, your searches, and other actions on All-Wall.com's Platform.
- **Device Information.** We automatically collect device information when you access our website or mobile applications, even if you have not created a All-Wall.com account or logged in. That information includes, among other things: your IP address, operating system version, device type, system and performance information, and browser type. Additionally, certain services include a unique application number. This number and information about your installation may be sent to All-Wall.com when you install or

uninstall a certain service or when a service periodically contacts our servers, such as for updates.
